The Strategy

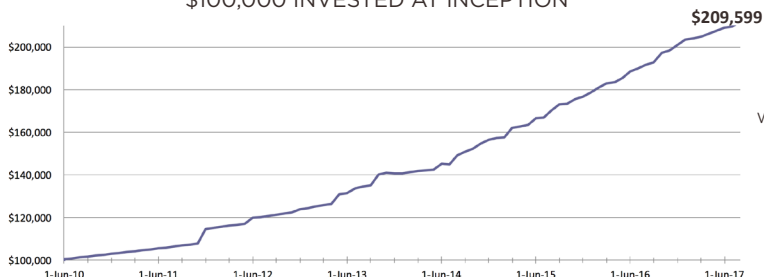

The Manager

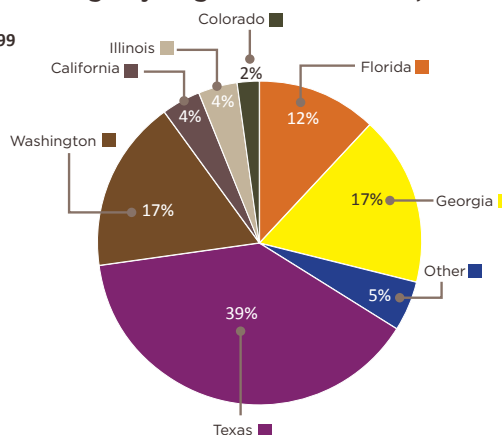

Holdings By Region as of June 30, 2017

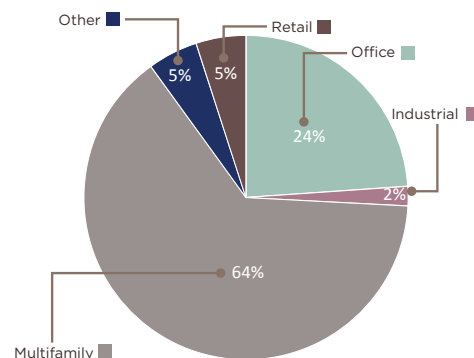
