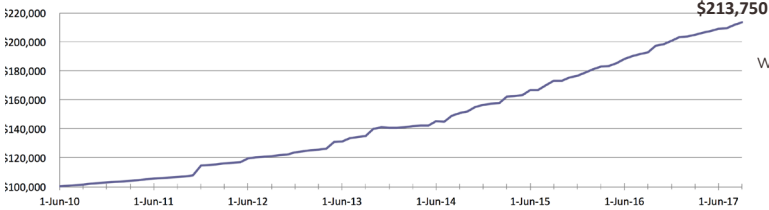
The Strategy

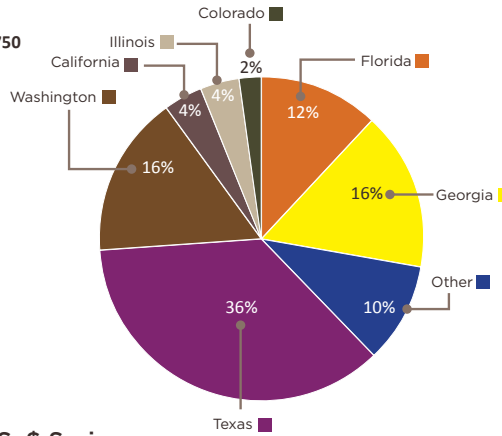
The Manager

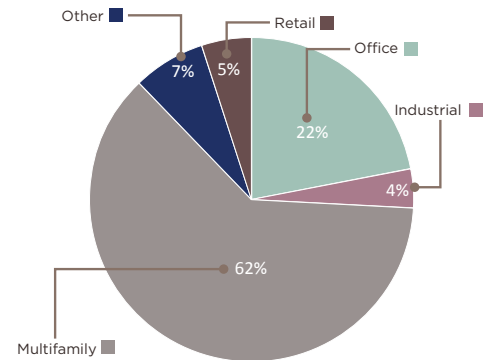
