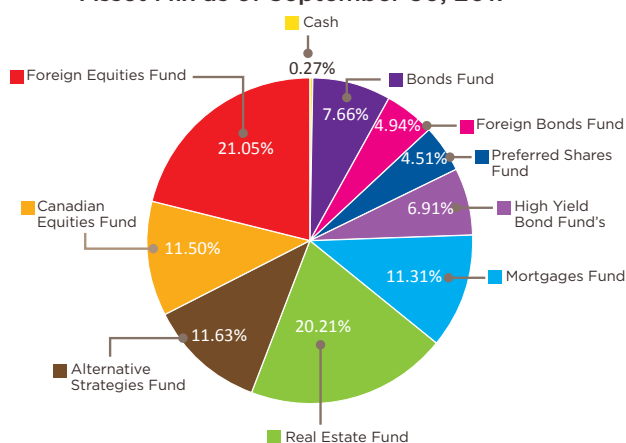
### The Strategy

The Manager will strategically allocate assets among various assets classes as per the NWM Asset Mix Committee's view of the near-term and long-term macro environments.

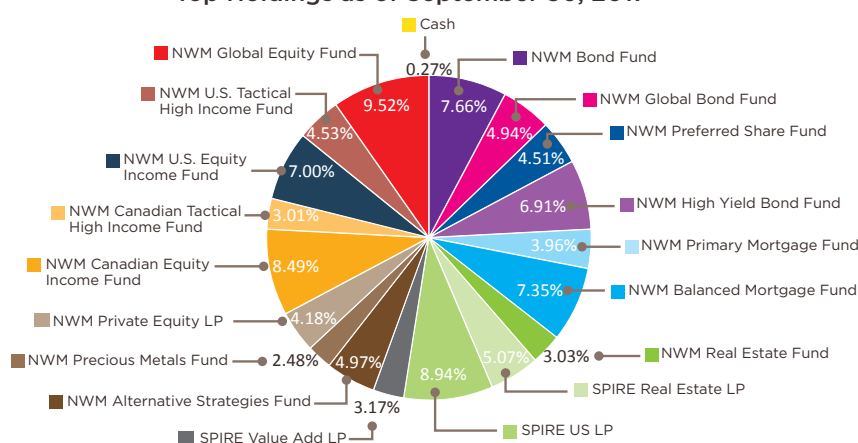
### The Manager

Asset Mix as of September 30, 2017<sup>†</sup>

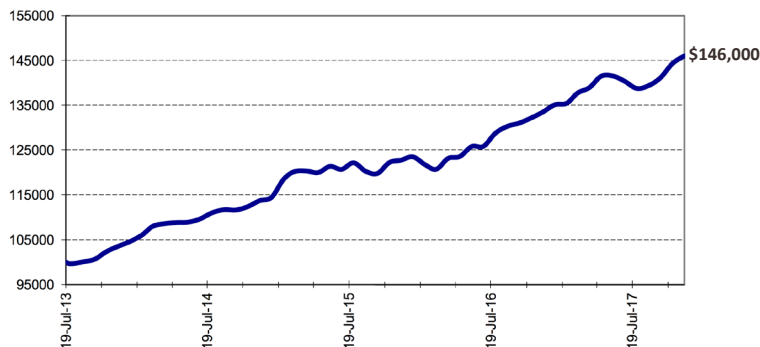


Top Holdings as of September 30, 2017
